



**IMPORTANT DATES
ELECTION 2018
State Election
Primary Election – August 7, 2018
General Election – November 6, 2018**

- June 1: **Filing and Withdrawal Deadline** (12 noon). Ten weeks prior to the general election. KSA 25-205; KSA 25-305(a), KSA-306(a)
Deadline for questions to be placed on the Primary Election ballot.
- June 1: No Party Affiliation changes from Noon, June 1st -Sept. 1st, Unaffiliated voters can affiliate at any time (KSA 25-3304 (b))
- June 22: **Deadline to mail Federal Service Ballots- 45 days before Election**
- July 17: **Registration books close.** Last day to register. KSA 25-2311(3)
- July 18: **Advance Voting by Mail begins** – 20 days prior to election. KSA 25-1122(f), KSA 25-1123(a)
- July 18: **Advance Voting In Person at the County Office Building.**
- August 6: **Advance voting closes (12 noon)** KSA 25-1122(f)
Filing deadline for Independent nominations (12 noon) KSA 25-305(b)
Filing deadline for District Court Judges Retention of Judges (12 noon) KSA 20-2908
- August 7: PRIMARY ELECTION. First Tuesday in August in even numbered years**
- August 13: Primary Canvass. KSA 25-3104
- Sept 1: ***Deadline for questions to be placed on the General Election ballot.**
- Sept 7: Filing deadline for Supreme Court and Court of Appeals judges to file for retention
- Sept 11: Filing Deadline for Improvement District Director Filing (12 Noon)
Tuesday preceding by eight (8) weeks of the General Election.
- Sept. 22: Deadline to mail out Federal Service Ballots (45 days prior to election)
- October 16: **Registration Books Close.** Last day to register. KSA 25-2311(a)(3)
- October 17: **Advance Voting by Mail begins** – 20 day prior to election. KSA 25-1122(f), KSA 25-1123(a)
- October 17: **Advance Voting In Person at the County Office Building.**
- November 5: **Advance Voting Closes** (12:00 Noon)
- November 6: **GENERAL ELECTION. Tuesday after the first Monday in November of even years.**
- November 15: **General Canvass** KSA 25-3104
