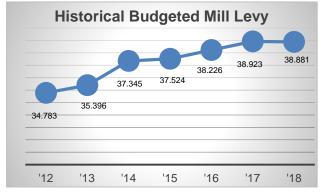

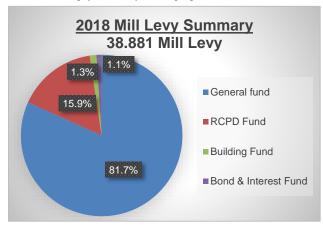
RILEY COUNTY MILL LEVY

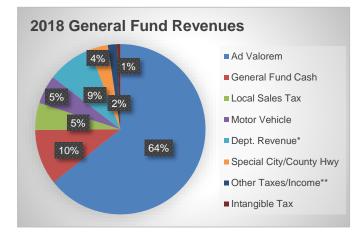
The chart below depicts historical mill levy rates. Assessed valuation for the 2018 budget is 629,553,040, an increase of 3.25% over last year's actual assessed valuation.

Since 2002, Riley County has lost an estimated \$39,473,749 in state revenues due to the elimination of LAVTR, Revenue Sharing, City/County Highway, CIME Reimbursement, Business & Machinery, Vehicle Tax & Mortgage Registration Fee changes plus the impact of unfunded mandates from the state.



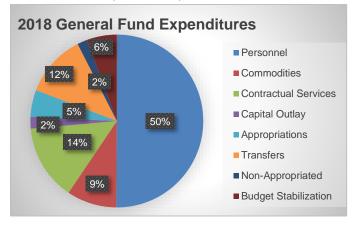
The chart below shows the breakdown of Riley County's Mill Levy, the majority of which is within the General fund. Riley County department's personnel services and operating expenditures are budgeted within the General fund along with agency appropriations. The 2018 General fund budgeted expenditures are listed in the far right column. The RCPD fund includes the County's 20% funding requirement as well as inmate medical and facility costs. Bond & Interest funds the county's debt obligations. The County Building fund is used to pay for county building repair/maintenance costs.





Departmental Revenues*: 21st Judicial District Receipts and Fees for Mortgage Registration/Recording, Diversions, Public Works, Fair, Attorney, Elections, Noxious Weed, Planning & Development, Register of Deeds, Appraiser, Treasurer, Clerk, Juvenile Supervision & Emergency Mngmt.

Other Taxes & Income**: Recreational Vehicle Tax, 16/20 Motor Vehicle Tax, Interest Income, Vehicle Rental Excise Tax, Franchise Fees, Interest on Tax, Commercial Vehicle Fees, Watercraft Fees, & PILT Federal Aid.



Appropriations to Various Agencies include:

ATA Bus, Big Lakes Developmental Center, Emergency Shelter, Pawnee Mental Health, Riley County Area Agency on Aging, Riley County Conservation District, Riley County Genealogical Society, Riley County Extension and Russell T. Reitz Animal Shelter.

<u>Non-Appropriated Balance</u>: Per Statute 79-2927, each fund is limited to 5% of total fund expenditures.

Transfers: General Fund to CIP, Economic Development, Health Department and Landfill Closure
