ELECTION 2022
State Election
Primary Election – August 2, 2022
General Election – November 8, 2022**

- June 1:** **Filing and Withdrawal Deadline**, (12 noon). KSA 25-205 & 305(a) & 306(a)
Deadline for questions to be placed on the Primary Election ballot
- June 10:** **Party declaration changes deadline for Dems and Republicans (12 noon). Prohibited until Sept. 1st, 2022 Unaffiliated may affiliate at any time.** HB 2210 (Date change due to redistricting)
- June 18:** **Deadline to mail Federal Service Ballots** KSA 25-1220
- July 12:** **Registration Books Close** Last day to register. KSA 25-2311(3)
- July 13:** **Advance voting by mail begins** – 20 days prior to Election Day. KSA 25-1122(f), KSA 25-1123(a)
- July 13:** **Advance voting in person begins**
- July 26:** **Last day to apply for an advance mail ballot.**
- August 1:** **Advance Voting Closes** (12:00 noon) KSA 25-122(g)
Filing deadline for Independent nominations (12:00 Noon) KSA 25-305(b)
Filing deadline for Retention of Judges (12:00 Noon) KSA 20-2908
- August 2:** **PRIMARY ELECTION. First Tuesday in August in even numbered years. KSA 25-203, KSA 25-2502(b)**
- August 15:** **Canvass Primary Election** KSA 25-3104
- September 1:** **Deadline for questions: to be placed on the General Election Ballot**
- September 1:** **Prohibition on changing party declaration ends. HB 2210**
- September 24:** **Deadline Mail Federal Service Ballots** KSA 25-1220
- October 11:** **Registration Books Close.** Last day to register. KSA 25-2311(a) (5)
- October 19:** **Advance voting by mail begins** – Ballots will be mailed 20 days prior to Election Day. KSA 25-1122(f), KSA 25-1123(a)
- October 19:** **Advance voting in person begins.**
- November 1:** **Last day to apply for an advance mail ballot.**
- November 7:** **Advance Voting Closes** (12:00 Noon) KSA 25-1122(f)
- November 8:** **GENERAL ELECTION. Tuesday after the first Monday in November in even numbered years**
KSA 25-101
- November 21:** **Canvass General Election. KSA 25-3104**
