Notice is hereby given that pursuant to K.S.A. 25-2018(e), a General Election will be conducted in Unified School District No. 378, Riley County, Kansas, on the 7th day of November 2023, for the purpose of electing Board of Education members for positions 1, 2, 3, and an At-Large position.
